OFFICIAL NOTICE:

LICENSE RENEWAL - PHARMACISTS AND INTERNS (1997-1998)

Applications for renewal of Ohio pharmacist and pharmacy intern licenses will be mailed during the first week of July 1997. If you do not receive your application for renewal by August 1, 1997, contact the Board office immediately at 614/466-4143.

Those pharmacists who must submit evidence of successfully completing 45 hours of continuing pharmacy education (4.5 CEUs) in order to renew their licenses this year (03-<u>3</u>-XXXX) will receive a continuing pharmacy education report form with their application for renewal. Remember, two hours (0.2 CEU) of the continuing pharmacy education reported must be in Board-approved jurisprudence.

Applications that have been completed as required and returned with the renewal fee and any other required documentation prior to the August 15, 1997 due date will be processed upon receipt. The 1997-1998 license will be mailed well in advance of September 15, 1997, which is the date the current license lapses.

EXECUTIVE DIRECTOR POSITION OPENING

The Ohio State Board of Pharmacy is accepting applications for the position of Executive Director. In order to qualify for this position, the individual must have a current license to practice pharmacy in Ohio or be eligible for licensure by examination or reciprocity. The person holding this position is, by Ohio law, the chief administrative officer of the Ohio State Board of Pharmacy and is responsible for directing and carrying out its legal responsibilities as a state licensing, regulatory, and drug law enforcement agency.

The Ohio Pharmacy Board is an autonomous state agency having the responsibility for administering and enforcing the following state laws: Pharmacy Practice Act; Dangerous Drug Distribution Act; Controlled Substance Act; Pure Food and Drug Act; and the Criminal Code Chapter titled "Drug Crimes". Pursuant to these laws, the Ohio Pharmacy Board licenses pharmacists; pharmacy interns; dangerous drug distributors, both wholesale and terminal; and controlled substance wholesalers and manufacturers.

The Pharmacy Board is the single state agency in Ohio responsible for administering and enforcing all of the laws governing the legal distribution of drugs (prescription, over-thecounter, and injectables) for human use. These laws mandate that the Board investigate any violations of these laws and, upon probable cause, file a complaint in an appropriate court for prosecution. The Pharmacy Board has also been given a significant number of other provisions to carry out its responsibilities. These include the authority to inspect and to obtain injunctions and/or nuisance actions. In addition, the Pharmacy Board is authorized to issue licenses and impose disciplinary actions such as denying renewals, suspending or revoking licenses, and imposing monetary penalties.

More detailed information regarding the Pharmacy Board, its responsibilities and operations may be obtained by accessing the Board's Home Page on the World Wide Web and reviewing the most current annual report to the Ohio Pharmacists Association.

Interested applicants should submit their current curriculum vitae to the President of the Board with a cover letter expressing their interest in the position <u>no later than</u> <u>December 31, 1997</u> (Ohio State Board of Pharmacy; 77 South High Street, 17th Floor; Columbus, OH 43266-0320). Once viable candidates have been identified through a review of the curriculum vitae, a formal application packet will be forwarded to these candidates for completion and submission to the Search Committee. The formal applications will be reviewed by the committee and interviews conducted by the Board beginning in January, 1998.

The Executive Director's position will become vacant on December 31, 1998 and it is the Board's intention to fill the position by July 1, 1998 in order to provide a six-month transition period.
