**Ohio to Implement NarxCare Platform**

OARRS will be transitioning to Appriss Health's NarxCare® platform on November 20, 2017. The upgrade to OARRS will offer several key features, including scores that calculate a patient's possible risk of overdose and addiction, red flags to alert prescribers of a potential patient safety issue, interactive visualization of prescription data and the ability to search for local addiction treatment providers. **ASAP 4.2A Dispenser Guide Now Available**

Effective December 29, 2017, [rule 4729-37-05](#) will be amended to require the reporting of data to OARRS via the ASAP 4.2A Standard. This change will allow the reporting of diagnosis or procedure codes for opioid analgesic prescriptions as part of a new opioid prescribing initiative.

The dispenser guide outlining the ASAP4.2A elements needed for the inclusion of this data is now available and can be accessed here: [www.pharmacy.ohio.gov/ASAPupdate](http://www.pharmacy.ohio.gov/ASAPupdate). ICD-10 and CDT codes are reported in the DSP25 field. When no code is reported on the prescription, enter "NC" in the DSP25 field.

You may begin reporting in the ASAP 4.2A format now, as OARRS will accept both ASAP 4.2 and ASAP4.2A. Effective December 29, 2017, OARRS will only accept only ASAP4.2A.

**Approval of Electronic Prescription Transmission Systems and Computerized Order Entry Systems**

Effective October 16, 2017, the State of Ohio Board of Pharmacy has updated its policy regarding the approval of electronic prescription transmission systems (EPTS) & computerized prescriber order entry systems (CPOE) to coincide with the implementation of upcoming revisions to rule 4729-5-30 of the Ohio Administrative Code (effective 12.29.2017).
