



## Ohio Licensed Outsourcing Facilities

**Updated 3-8-2016**

The Drug Quality and Security Act, signed into law on November 27, 2013, created a new section 503B in the United States Federal Food, Drug, and Cosmetic Act. Under section 503B, a compounding can become an "outsourcing facility."

The law defines an "outsourcing facility" as a facility at one geographic location or address that is engaged in the compounding of sterile drugs; has elected to register with the FDA as an outsourcing facility; and complies with all of the requirements of section 503B.

These facilities are permitted to provide non-patient specific compounded sterile drug products that must meet current good manufacturing practice (CGMP) requirements. A list of registered FDA outsourcing facilities can be accessed here:

**Pursuant to OAC 4729-16-02, an outsourcing facility is prohibited from selling compounded products in Ohio unless they hold a valid license as wholesale distributor of dangerous drugs with an outsourcing facility classification.** The following is a list of FDA registered outsourcing facilities currently permitted to ship compounded products into Ohio:
