

## JURISPRUDENCE C.P.E. REPORTING REQUIREMENTS

(05/09/2008)

"Pharmacy jurisprudence" related continuing education shall include Ohio State Board of Pharmacy approved continuing pharmacy education experiences that deal with current laws, rules, and regulations dealing with the practice of pharmacy and the recent changes that have occurred to those laws, rules, and regulations. (4729-7-01(F) OAC)

Pursuant to Rule 4729-7-02(A) of the Ohio Administrative Code, at least 0.3 CEUs (3 hours) of the total CEUs required for the renewal of a pharmacist identification card must be Ohio Board of Pharmacy approved programs in jurisprudence. Pharmacists registered with the Ohio Board of Pharmacy who do not practice in Ohio and have met the mandatory continuing education requirements of another state where they hold a current license to practice pharmacy are not required to complete Ohio Board approved jurisprudence if they sign the waiver statement as stated in Rule 4729-7-01(F) of the Ohio Administrative Code.

A list of Ohio Board of Pharmacy approved jurisprudence programs can be found on the Ohio Board of Pharmacy's website under "C.P.E. News and S.B.N.". **It is the responsibility of the pharmacist** to verify that they have obtained Ohio Board approved pharmacy jurisprudence prior to submitting a continuing education report form.

The following is a list of Ohio-based C.P.E. providers that have Ohio Board of Pharmacy approved jurisprudence programs available by correspondence. There are a number of national providers that have also submitted programs for review and have been approved by the Ohio Board of Pharmacy. These programs can be found on the list of Ohio Board of Pharmacy approved jurisprudence programs. Not all jurisprudence programs have been approved and the pharmacist must verify the program on the Board's website.
