FINDINGS OF FACT

After having heard the testimony, considered the evidence, observed the demeanor of the witnesses, and weighed their credibility, the State Board of Pharmacy finds the following to be fact:

- (1) Records of the Board of Pharmacy indicate that Richard R. Bonfiglio was originally licensed in the state of Ohio on July 31, 1956, pursuant to examination, and is currently licensed to practice pharmacy in Ohio.
- (2) Richard R. Bonfiglio was, on or about April 17, 1991, convicted in the Cuyahoga County Common Pleas Court of one count of mislabeling prescriptions in violation of Section 4729.38(B) of the Ohio Revised Code, a minor misdemeanor.

CONCLUSION OF LAW

- (1) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraph (2) of the Findings of Fact constitutes having been convicted of a misdemeanor related to, or committed in the practice of pharmacy as provided in Division (A)(4) of Section 4729.16 of the Ohio Revised Code.

ACTION OF THE BOARD

Pursuant to Section 4729.16 of the Ohio Revised Code, the State Board of Pharmacy takes the following actions in the matter of Richard R. Bonfiglio:

(A) On the basis of the Findings of Fact and Conclusion of Law set forth above, the State Board of Pharmacy hereby places the identification card, No. 03-1-13507, held by Richard R. Bonfiglio on probation for five years effective as of the date of the mailing of this Order. The terms of probation are as follows:

- (1) Richard R. Bonfiglio must not violate the drug laws of the state of Ohio, any other state, or the federal government;
- (2) Richard R. Bonfiglio must abide by the rules of the State Board of Pharmacy; and
- (3) Richard R. Bonfiglio must comply with the terms of this Order.

Pursuant to paragraph (D)(1) of Rule 4729-3-01 of the Ohio Administrative Code, the State Board of Pharmacy hereby declares that Richard R. Bonfiglio's pharmacist identification card is not in good standing and thereby denies the privilege of being a preceptor and training pharmacy interns for a period of five years effective as of the date of the mailing of this Order.

THIS ORDER WAS APPROVED BY A VOTE OF THE STATE BOARD OF PHARMACY (Aye-6/Nay-0).



THE MATTER OF RICHARD R. BONFIGLIO, DOCKET NO. 6-166-3, WAS HEARD PURSUANT TO CHAPTERS 119. AND 4729. OF THE REVISED CODE ON THURSDAY, JUNE 26, 1986. AFTER CONSIDERATION OF THE EVIDENCE ADDUCED, MOTIONS WERE MADE AND RECORDED THAT THE FOLLOWING ORDER BE ADOPTED:

ORDER

Findings Of Fact

- (1) From the evidence presented, the State Board of Pharmacy finds that Richard R. Bonfiglio, as the president of Bonfiglio Pharmacy Company, Inc., 530 S. Broadway, Greenville, Ohio and as a practicing pharmacist, is responsible for compliance with all state and federal laws regulating the distribution of drugs and the practice of pharmacy at Bonfiglio Pharmacy Company, Inc., Terminal Distributor of Dangerous Drugs License No. 02-128150, pursuant to Ohio Revised Code Section 2901.24 and Ohio Administrative Code Rule 4729-5-23.
- (2) From the evidence presented, the State Board of Pharmacy finds that Bonfiglio Pharmacy Company, Inc. did, between the dates of August 24, 1983 and May 29, 1985, receive in commerce misbranded drugs, hold and offer for sale, and sell misbranded drugs, to wit: misbranded drugs were purchased on at least 60 different occasions from Tri-State Pharmaceutical, 625 N. Wayne, Cincinnati, Ohio in plastic prescription vials and were dispensed to patients pursuant to written or oral prescriptions. Such conduct is in violation of Ohio Revised Code Section 3715.64(A) and is prohibited by Section 3715.52 of the Ohio Revised Code.
- (3) From the evidence presented, the State Board of Pharmacy finds that Bonfiglio Pharmacy Company, Inc. did, between the dates of October 12, 1983 through May 7, 1985, receive in commerce misbranded drugs, hold and offer for sale, and sell misbranded drugs, to wit: drugs were purchased on at least 15 different occasions from Tri-State Pharmaceutical, 625 N. Wayne, Cincinnati, Ohio and were dispensed to patients pursuant to written or oral prescriptions. These drugs were misbranded; in that, they were labeled as "clinic packs" and/or as "samples" and, therefore, were false and misleading when sold at retail. Such conduct is in violation of Ohio Revised Code Sections 3715.64(A) and 3719.81, and is prohibited by Sections 3715.52 and 2925.36 of the Ohio Revised Code.

STATE BOARD OF PHARMACY

- (4) From the evidence presented, the State Board of Pharmacy finds that Bonfiglio Pharmacy Company, Inc. did, between the dates of August 7, 1985 and November 20, 1985, receive in commerce misbranded drugs, hold and offer for sale, and sell at retail misbranded drugs, to wit: drugs were purchased on at least 5 different occasions from Miami-Luken, Inc., 601 N.W. 5th Street, Box 100, Richmond, Indiana and were dispensed to patients pursuant to written or oral prescriptions. These drugs were misbranded; in that, they were labeled "For Hospital Use Only" and, therefore, were false and misleading. Such conduct is in violation of Ohio Revised Code Section 3715.64(A) and is prohibited by Section 3715.52 of the Ohio Revised Code.

Conclusions Of Law

- (1) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that the conduct set forth in paragraphs (2) through (4) of the Findings Of Fact constitutes unprofessional conduct in the practice of pharmacy.
- (2) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that the conduct set forth in paragraphs (2) through (4) of the Findings Of Fact constitutes violating the provisions of Chapters 2925., 3715. and 3719. of the Ohio Revised Code.

Pursuant to Section 4729.16 of the Ohio Revised Code, and the foregoing Findings of Fact and Conclusions Of Law, the State Board of Pharmacy takes the following actions concerning the pharmacist license held by Richard R. Bonfiglio, No. 03-1-06212:

- (A) On the basis of paragraph (1) of the Conclusions Of Law set forth above, the State Board of Pharmacy hereby suspends the pharmacist identification card held by Richard R. Bonfiglio for 12 months, effective October 1, 1986.
- (B) On the basis of paragraph (2) of the Conclusions Of Law set forth above, the State Board of Pharmacy hereby imposes a monetary penalty of two thousand five hundred dollars (\$2,500.00), due and owing within thirty (30) days of the issuance of this Order. Said monetary penalty should be made payable to the "Treasurer, State of Ohio" and mailed to the State Board of Pharmacy, 65 S. Front Street, Room 504; Columbus, Ohio 43266-0320, with the enclosed form.
- (C) Further, the Board suspends the suspension on condition that Richard R. Bonfiglio:

STATE BOARD OF PHARMACY

- (1) takes and successfully completes the Jurisprudence examination offered by the Board on September 23, 1986;
- (2) does not violate any drug laws of the state of Ohio, any other state, or the federal government; and
- (3) abides by the rules of the State Board of Pharmacy.

THIS ORDER WAS APPROVED BY A VOTE OF THE STATE BOARD OF PHARMACY.
