## THE STATE BOARD OF PHARMACY

VS

VERLON O. AGAN JR.

THE MATTER OF THE STATE BOARD OF PHARMACY VERSUS MR. VERLON O. AGAN JR., DOCKET NO. 6-13-3, WAS HEARD PURSUANT TO CHAPTERS 4729 AND 119, REVISED CODE. AFTER CONSIDERATION OF THE EVIDENCE ADDUCED, MOTION WAS MADE AND RECORDED THE FOLLOWING ORDER BE ADOPTED:

### ORDER

- (1) THE STATE BOARD OF PHARMACY FINDS MR. VERLON O. AGAN JR. IS GUILTY OF CHARGES A, B, C, D, CONTAINED IN THE CITATION AND DID VIOLATE SECTION 3715.64(A), (1), REVISED CODE, ONE TIME AND SECTION 3715.64(A), (9), (d), REVISED CODE, THREE TIMES.
- (2) THE STATE BOARD OF PHARMACY FINDS MR. VERLON O. AGAN JR. DID VIOLATE SECTION 4729.16(C), REVISED CODE, IN THAT HE WILLFULLY VIOLATED MORE THAN ONE TIME ANY OF THE PROVISIONS OF SECTIONS 3715.52 TO 3715.72, OF THE REVISED CODE.
- (3) THE STATE BOARD OF PHARMACY FINDS UNDER SECTION 4729.16, REVISED CODE, THE STATE BOARD OF PHARMACY, AFTER NOTICE AND HEARING IN ACCORDANCE WITH SECTIONS 119.01 TO 119.13, INCLUSIVE, OF THE REVISED CODE, MAY REVOKE, SUSPEND, OR REFUSE TO GRANT AN IDENTIFICATION CARD OR RENEWAL IDENTIFICATION CARD UNDER THIS CHAPTER, OR MAY IMPOSE A MONETARY PENALTY OR FORFEITURE NOT TO EXCEED IN SEVERITY ANY FINE DESIGNATED UNDER THE REVISED CODE FOR A SIMILAR OFFENSE, IF A MAJORITY OF THE MEMBERS OF THE BOARD FIND A PHARMACIST OR PHARMACY INTERN:
  - (C) GUILTY OF WILLFULLY VIOLATING MORE THAN ONE TIME ANY OF THE PROVISIONS OF SECTIONS 3715.52 TO 3715.72, OF THE REVISED CODE.
  - (4) THE STATE BOARD OF PHARMACY FINES MR. VERLON O. AGAN JR. \$100 EACH ON CHARGES A, B, C, D CONTAINED IN THE CITATION FOR A TOTAL OF \$400.
  - (5) THE STATE BOARD OF PHARMACY SUSPENDS THE \$400 FINE.

THE ORDER WAS APPROVED BY A ROLL CALL VOTE OF THE STATE BOARD OF PHARMACY.
