THE MATTER OF SIYANBOLA ABIMBOLA OLAGBAJU, R.Ph., DOCKET NO. 6-63-2, CAME ON FOR CONSIDERATION BY THE BOARD OF PHARMACY ON SATURDAY, OCTOBER 15, 1983. MOTIONS WERE MADE AND RECORDED THE FOLLOWING ORDER BE ADOPTED:

ORDER

- (1) On May 13, 1983, a Notice of Opportunity for a Hearing was forwarded by the State Board of Pharmacy by certified mail, return receipt requested, to Siyanbola Abimbola Olagbaju, R.Ph.; 1145 S. Byrne Road, Apt. 13; Toledo, Ohio 43614.
- (2) As demonstrated by certified letter P34 9363761, which was returned by the postal service marked "Return To Sender, Box Closed", and which was received by the Board of Pharmacy office on May 23, 1983 at 1:52 p.m., the Board was unable to deliver the Notice required by Section 119.07 of the Ohio Revised Code.
- (3) As demonstrated by a certified letter dated August 16, 1983, the State Board of Pharmacy requested the Toledo Blade to publish a "Notice of Opportunity for a Public Hearing" in the legal notices section once a week for a period of three weeks beginning Wednesday, August 24, 1983 and the following two Wednesdays, in accordance with the provisions of Section 119.07 of the Ohio Revised Code.
- (4) As demonstrated by the return receipt of April 18, 1983, the Toledo Blade, 541 Superior Street, Toledo, Ohio 43604, received the request for publication of the "Notice of Opportunity for a Public Hearing" regarding Siyanbola Abimbola Olagbaju, R.Ph.
- (5) As demonstrated by the notarized proof of publication received from the Toledo Blade by the State Board of Pharmacy on September 12, 1983, the "Notice of Opportunity for a Public Hearing" was published once a week for three weeks in a newspaper of general circulation in Lucas County, the county where the last known place of residence of Siyanbola Abimbola Olagbaju, R.Ph. is located.
- (6) A copy of the Notice with the date of first publication marked was mailed to Siyanbola Abimbola Olagbaju, R.Ph., 1145 S. Byrne, Apt. 13, Toledo, Ohio 43614.
- (7) As of October 15, 1983, Siyanbola Abimbola Olagbaju, R.Ph., has not responded in any way to the "Notice of Opportunity for a Public Hearing", which was published in the Toledo Blade on the 24th and 31st of August, and September 7, 1983 informing him of the allegations against him.

- (8) Upon consideration of the allegations against Siyanbola Abimbola Olagbaju, R.Ph., and his failure to request a hearing, submit his position, contentions, or arguments in writing, or to otherwise deny the allegations against him, the State Board of Pharmacy concludes that Siyanbola Abimbola Olagbaju did engage in the conduct alleged in the Notice of Opportunity for a Public Hearing, and the Board further concludes that:
- (a) Said conduct constitutes gross immorality within the meaning of Section 4729.16(A) of the Revised Code;
 - (b) Said conduct constitutes willful violation of more than one time of the provisions of Sections 3715.52 to 3715.72, and Chapters 2925., 3719., and 4729. of the Revised Code; and,
 - (c) Said conduct constitutes permitting a person other than a pharmacist or pharmacy intern to practice pharmacy.

Pursuant to Divisions (A), (C), and (D) of Section 4729.16 of the Ohio Revised Code, the State Board of Pharmacy hereby revokes the pharmacist identification card of Siyanbola Abimbola Olagbaju, effective immediately.

THIS ORDER WAS APPROVED BY A VOTE OF THE STATE BOARD OF PHARMACY.
