FINDINGS OF FACT

- (1) On March 2, 1993, Theresa Marie Limoges was notified by letter of her right to a hearing, her rights in such hearing, and her right to submit her contentions in writing.
- (2) As demonstrated by return receipt of March 23, 1993, Theresa Marie Limoges received the letter of March 2, 1993, informing her of the allegations against her, and her rights.
- (3) Theresa Marie Limoges has not responded in any manner to the letter of March 2, 1993, and has not requested a hearing in this matter.

Order of the Board

- (4) Upon consideration of the record as a whole, the State Board of Pharmacy finds that Theresa Marie Limoges has not continued her pharmacy education in accordance with Chapter 4729-7 of the Ohio Administrative Code.
- (5) Upon consideration of the record as a whole, the State Board of Pharmacy finds that Theresa Marie Limoges has not submitted the required 4.5 Continuing Education Units needed for renewal of her license to practice pharmacy in Ohio.

CONCLUSION OF LAW

- (1) The State Board of Pharmacy concludes that paragraphs (4) and (5) of the Findings of Fact constitute failure to meet the requirements for a renewal identification card as set forth in Section 4729.12 of the Ohio Revised Code.

ACTION OF THE BOARD

Pursuant to Section 4729.12 of the Ohio Revised Code, the State Board of Pharmacy hereby denies the issuance of a pharmacist renewal identification card to practice pharmacy in the state of Ohio for the period of September 15, 1993, through September 15, 1994.

It is hereby certified by this Board that the above language is a copy of the Order entered upon its journal in this case.

Section 119.12 of the Revised Code authorizes an appeal from this Order. Such an appeal may be taken to the court of common pleas in the county in which your place of business is located or to said court of the county in which you reside. If you do not have a place of business in Ohio and are not a resident of Ohio, you may appeal to the Court of Common Pleas in Franklin County, Ohio.

Such an appeal, setting forth the order appealed from and the grounds of the appeal, must be commenced by the filing of a Notice of Appeal with the State Board of Pharmacy and the appropriate court within fifteen (15) days after the mailing of this notice and in accordance with the requirements of Section 119.12 of the Revised Code.
