THE MATTER OF THE STATE BOARD OF PHARMACY VERSUS ALBERT D. SHEARS, DOCKET NUMBER 5-421-2, WAS HEARD PURSUANT TO CHAPTER 119, R.C. MOTION WAS MADE AND RECORDED THAT THE FOLLOWING ORDER BE ADOPTED:

ORDER

1. ALBERT D. SHEARS IS GUILTY OF ELEVEN VIOLATIONS OF THE REVISED CODE AS CHARGED IN THE STATE BOARD OF PHARMACY LETTER OF MAY 25, 1972.
2. PURSUANT TO SECTIONS 4729.16, 4729.28 and 4729.99(C), R.C., ALBERT D. SHEARS IS FINED \$100.00 ON CHARGE NUMBER ONE AND \$300.00 EACH ON CHARGES NUMBER TWO THROUGH SEVEN.
3. PURSUANT TO SECTIONS 4729.16, 3715.64 and 3715.99(A), R.C., ALBERT D. SHEARS IS FINED \$100.00 ON CHARGE NUMBER EIGHT AND \$300.00 ON CHARGES NUMBER NINE THROUGH ELEVEN.
4. THE FINES ON CHARGES NUMBER TWO THROUGH NUMBER SEVEN AND CHARGES NUMBER NINE THROUGH NUMBER ELEVEN SHALL BE SUSPENDED UPON PAYMENT BY ALBERT D. SHEARS, WITHIN THIRTY (30) DAYS FROM THE DATE OF RECEIPT OF THIS ORDER, OF THE \$200.00 FINES FOR CHARGES NUMBER ONE AND NUMBER EIGHT.

THE MOTION WAS UNANIMOUSLY APPROVED BY A ROLL CALL VOTE OF THE STATE BOARD OF PHARMACY.

THE MATTER OF THE STATE BOARD OF PHARMACY VERSUS MR. ALBERT D. SHEARS, DOCKET NO. 6-30-1 WAS HEARD PURSUANT TO CHAPTERS 4729 AND 119, REVISED CODE. AFTER CONSIDERATION OF THE EVIDENCE ADDUCED, MOTION WAS MADE AND RECORDED THE FOLLOWING ORDER BE ADOPTED:

ORDER

- (1) THE STATE BOARD OF PHARMACY FINDS ALBERT D. SHEARS DID VIOLATE SECTION 4729.27 OF THE OHIO REVISED CODE.
- (2) THE STATE BOARD OF PHARMACY FINES ALBERT D. SHEARS \$500.
- (3) THE STATE BOARD OF PHARMACY FINDS ALBERT D. SHEARS IS GUILTY OF VIOLATION OF SECTIONS 4729.16(D), 3719.12 AND 4729.16(C), REVISED CODE.
- (4) THE STATE BOARD OF PHARMACY SUSPENDS THE IDENTIFICATION CARD OF ALBERT D. SHEARS FOR NINETY (90) DAYS, EFFECTIVE MARCH 28, 1977, ON EACH OF COUNTS 2, 3, AND 4 OF THE CITATION, THE SUSPENSION ON EACH OF THESE COUNTS TO OCCUR CONCURRENTLY.
- (5) THE BOARD ORDERS RETURN OF THE IDENTIFICATION CARD AND CERTIFICATE OF REGISTRATION OF ALBERT D. SHEARS TO THE STATE BOARD OF PHARMACY WITHIN 10 DAYS OF THE EFFECTIVE DATE OF THIS ORDER.

THIS ORDER WAS APPROVED BY A ROLL CALL VOTE OF THE STATE BOARD OF PHARMACY.
