THE MATTER OF FOUAD KAMEL ASAAD CAME ON FOR CONSIDERATION BY THE STATE BOARD OF PHARMACY ON MARCH 5, 1991. MOTIONS WERE MADE AND RECORDED THAT THE FOLLOWING ORDER BE ADOPTED:

ORDER

State's Exhibits

- (3) Exhibit 2 - First Notice to Comply with Audit letter dated November 5, 1990.
- (4) Exhibit 3 - Second Notice to Comply with Audit letter dated November 29, 1990.

Findings Of Fact

- (1) On January 10, 1991, Fouad Kamel Asaad was notified by letter of his right to a hearing, his rights in such hearing, and his right to submit his contentions in writing.
- (2) As demonstrated by return receipt of January 16, 1991, Fouad Kamel Asaad received the letter of January 10, 1991 informing him of the allegations against him, and his rights.
- (3) Fouad Kamel Asaad has not responded in any manner to the letter of January 10, 1991 and has not requested a hearing in this matter.
- (4) Upon consideration of the record as a whole, the State Board of Pharmacy finds that Fouad Kamel Asaad, on or about September 1, 1990, submitted a Continuing Pharmacy Education Report Form providing documentation of his continuing pharmacy education in

another state pursuant to paragraph (F) of Ohio Administrative Code Rule 4729-7-02 with the application for renewal of a pharmacist identification card.

- (5) Upon consideration of the record as a whole, the State Board of Pharmacy finds that Fouad Kamel Asaad, on or about November 5, 1990, was notified that his continuing pharmacy education was being audited pursuant to paragraph (C) of Rule 4729-7-03 of the Ohio Administrative Code, and that he must provide evidence of the continuing pharmacy education documented on the Continuing Pharmacy Education Report Form submitted with his renewal application.
- (6) Upon consideration of the record as a whole, the State Board of Pharmacy finds that Fouad Kamel Asaad has not continued his pharmacy education in accordance with Rules 4729-7-01 through 4729-7-07 of the Ohio Administrative Code as required by Section 4729.12 of the Revised Code, to wit: Fouad Kamel Asaad has not provided the required evidence certifying that he has met the continuing pharmacy education requirements for renewal as documented on his Continuing Pharmacy Education Report Form.

Conclusion Of Law

- (1) The State Board of Pharmacy concludes that paragraph (6) of the Findings Of Fact constitutes unprofessional conduct in the practice of pharmacy as provided in Division (A)(2) of Section 4729.16 of the Ohio Revised Code.

Action of the Board

Pursuant to Section 4729.16 of the Ohio Revised Code, the State Board of Pharmacy hereby refuses to renew the pharmacist identification card, No. 03-2-11844, held by Fouad Kamel Asaad.

THIS ORDER WAS APPROVED BY A VOTE OF THE STATE BOARD OF PHARMACY.

It is hereby certified by this Board that the above language is a copy of the Order entered upon its journal in this case.

Section 119.12 of the Revised Code authorizes an appeal from this Order. Such an appeal may be taken to the court of common pleas in the county in which your place of business is located or to said court of the county in which you reside. If you do not have a place of business in Ohio and are not a resident of Ohio, you may appeal to the Court of Common Pleas in Franklin County, Ohio.


