Introduction

THE MATTER OF ALEXANDRIA D. KARAHALIOS CAME ON FOR CONSIDERATION BY THE STATE BOARD OF PHARMACY ON SEPTEMBER 26, 1991.

Findings Of Fact

- (1) On May 30, 1991, Alexandria D. Karahalios was notified by letter of her right to a hearing, her rights in such hearing, and her right to submit her contentions in writing.
- (2) As demonstrated by return receipt of April 4, 1991, Alexandria D. Karahalios received the letter of May 30, 1991 informing her of the proposal to deny internship credit for practical experience, and her rights.
- (3) Alexandria D. Karahalios has not responded in any manner to the letter of May 30, 1991, and has not requested a hearing in this matter.
- (4) Upon consideration of the record as a whole, the State Board of Pharmacy finds that records of the Board indicate that Alexandria D. Karahalios was originally licensed as an intern in the state of Ohio on September 27, 1989.

- (5) Upon consideration of the record as a whole, the State Board of Pharmacy finds that records of the Board indicate that Alexandria D. Karahalios' Practical Experience Affidavits for the following time period and hours worked were received on February 13, 1991 and March 4, 1991:

Records further indicate that the Board received Alexandria D. Karahalios' Statement of Preceptor form for the above-stated time period on March 4, 1991.

- (6) Upon consideration of the record as a whole, the State Board of Pharmacy finds that Alexandria D. Karahalios failed to file a Statement of Preceptor form within thirty days of beginning training as required by paragraph (G) of Rule 4729-3-01 of the Ohio Administrative Code.
- (7) Upon consideration of the record as a whole, the State Board of Pharmacy finds that Alexandria D. Karahalios has not submitted evidence of extraordinary circumstances as required by paragraph (G)(1) of Rule 4729-3-01 of the Administrative Code.

Conclusion Of Law

- (1) The State Board of Pharmacy concludes that paragraphs (5) through (7) of the Findings Of Fact constitute failure to meet the exemption clause as provided in paragraph (G)(1) of Rule 4729-3-01 of the Ohio Administrative Code.

Action Of The Board

Pursuant to Rule 4729-3-01 of the Ohio Administrative Code, the State Board of Pharmacy hereby refuses to accept an earlier filing date for the Statement Of Preceptor form submitted by Alexandria D. Karahalios on March 4, 1991, and therefore refuses to grant internship credit for practical experience obtained under the supervision of Joel A. M. Tavormina prior to February 2, 1991.

THIS ORDER WAS APPROVED BY A VOTE OF THE STATE BOARD OF PHARMACY (Aye-6/Nay-0).
