FINDINGS OF FACT

After having heard the testimony, observed the demeanor of the witnesses, considered the evidence, and weighed the credibility of each, the State Board of Pharmacy finds the following to be fact:

- (1) Records of the Board of Pharmacy indicate that Deeb M. E. Mashni applied to the Board for registration as an intern in the State of Ohio on September 13, 2004.
- (2) Deeb M. E. Mashni was, on or about October 27, 2002, charged with Aggravated Vehicular Homicide and Vehicular Assault. Deeb M. E. Mashni was found Incompetent to Stand Trial on January 29, 2003, and ordered to undergo treatment. Subsequently, on April 30, 2003, Deeb M. E. Mashni was found Not Guilty by Reason of Insanity and committed to an institution. State of Ohio v. Deeb Mashni, Case No. G-4801-CR-0200203328, Lucas County Common Pleas Court. Deeb M. E. Mashni has informed Board agents that he was "seeing spirits, hearing voices of [his] family, and other problems dealing with reality." Family members convinced Deeb M. E. Mashni to seek mental health help, and he was found to have mental problems; yet, Deeb M. E. Mashni refused medications and denied his condition. While in pharmacy school in the year 2002, Deeb M. E. Mashni "had trouble with classes because of hallucinations and delusions." The aforementioned criminal charges arose because Deeb M. E. Mashni killed someone in an automobile accident while driving his car "trying to get away from the Antichrist who was trying to kill him." Such condition indicates that Deeb M. E. Mashni is impaired physically or mentally to such a degree as to render him unfit to practice pharmacy within the meaning of Section 4729.16 of the Ohio Revised Code.

CONCLUSION OF LAW

The State Board of Pharmacy concludes that paragraph (2) of the Findings of Fact constitutes being impaired physically or mentally to such a degree as to render Deeb M.E. Mashni unfit to practice pharmacy as provided in Division (A)(3) of Section 4729.16 of the Ohio Revised Code.

DECISION OF THE BOARD

Pursuant to Section 4729.11 of the Ohio Revised Code, and after consideration of the record as a whole, the State Board of Pharmacy hereby denies the Application for Pharmacy Intern Registration submitted by Deeb M.E. Mashni on September 13, 2004.

THIS ORDER WAS APPROVED BY A VOTE OF THE STATE BOARD OF PHARMACY (Aye-7/Nay-1). MOTION CARRIED.

It is hereby certified by this Board that the above language is a copy of the Order entered upon its journal in this case.

Section 119.12 of the Ohio Revised Code authorizes an appeal from this Order. An order that denied admission to an examination, or denied the issuance or renewal of a license or registration, or revoked or suspended a license, may be appealed to the court of common pleas in the Ohio county of your place of business or in your Ohio county of residence. Any other order may be appealed to the Court of Common Pleas of Franklin County, Ohio.

Such an appeal, setting forth the order appealed from and the grounds of the appeal, must be commenced by <u>filing the original Notice of Appeal</u> with the State Board of Pharmacy and a copy with the appropriate court <u>within fifteen (15) days after the mailing of this Order</u> and in accordance with the requirements of Section 119.12 of the Ohio Revised Code.
