State of Ohio Board of Pharmacy - Rule Reorganization Crosswalk

Updated 2/2/2022

In 2016, the State of Ohio Board of Pharmacy voted to authorize the reorganization of its administrative rules. The goal of this reorganization was to ensure that licensees could better identify rules applicable to the various practice settings/professions regulated by the Board.

To accomplish this, the Board created the following new divisions in the Ohio Administrative Code:

Division	Applicability
4729 - State Board of Pharmacy	Applicable to the operation of the Board.
4729:1 - Pharmacists	Applicable to pharmacist licensure, practice, and discipline.
4729:2 - Pharmacy Interns	Applicable to pharmacy intern licensure, practice, and discipline.
4729:3 - Pharmacy Technicians	Applicable to pharmacy technician licensure, practice, and discipline.
4729:4 - Impaired Licensees and Registrants	Applicable to licensees and registrants who are subject to probation by the Board.
4729:5 - Terminal Distributors of Dangerous Drugs	Applicable to the licensure, operation, and discipline of terminal distributors of dangerous drugs (outpatient pharmacies, institutional pharmacies, non-resident pharmacies, prescriber clinics, EMS, etc.).
4729:6 - Distributors of Dangerous Drugs	Applicable to the licensure, operation, and discipline of distributors of dangerous drugs (wholesalers, manufacturers, 3PLs, outsourcing facilities, etc.).
4729:7 - Drug Compounding	Applicable to pharmacies and prescribers engaged in drug compounding.
4729:8 - Drug Database	Applicable to the operation of the Ohio Automated Rx Reporting System (OARRS) and licensees who are required by Ohio law to report information to the system.

4729:9 - Controlled Substances and Drugs of Concern	Includes Ohio's controlled substance schedules and regulations governing the sale and distribution of ephedrine products.
4729:10 - Prescription Drug Collection	Applicable to pharmacies and law enforcement operating prescription drug collection programs.
4729:11 - Home Medical Equipment Service Providers	Applicable to the licensure/registration, operation, and discipline of home medical equipment service providers.

About Ohio's Rule Numbering System

Ohio's rule-numbering system is the practical means by which the Administrative Code is organized.

All rules must be numbered in conformity with the numbering system. A rule number is comprised of the following parts:

- 1. **Agency number:** The agency number is the first tool for numerically organizing an agency's rules into the Administrative Code. When possible, it corresponds to the Revised Code chapter from which an agency principally derives its rule-making authority (for the Board this is ORC 4729).
- 2. **Division number:** A division is assigned a division number for the purpose of organizing an agency's rules into the Administrative Code. This number follows the agency number and is preceded by a colon.
- 3. **Chapter number:** A chapter contains the individual rules that pertain to a particular subject. Each chapter is assigned a number, typically a one- or two-digit number, which follows the agency or division number and is preceded by a hyphen. (Chapters one to nine are numbered as -1, -2, and so forth.)


4. Rule number:

- a. Principal rule number: Two- and sometimes three-digit rules are called "principal rules."
- b. **Supplemental rule number:** Rule is assigned an additional digit when it is a "supplemental rule," meaning the rule amplifies or elaborates upon the provisions of a principal rule. In this case, the supplemental rule is given the principal rule number plus an additional number preceded by a decimal. (For example, -01.1 would be a supplemental rule to -01.)
