



COVID-19 Response Efforts: Webinar on Ordering, Storage and Handling of New Pediatric Pfizer and Moderna Vaccines

The Ohio Department of Health (ODH) is offering a webinar on **Tuesday, June 14, from 2-3pm** to inform COVID-19 vaccine providers of key updates about Pfizer-BioNTech's new pediatric formulation (ages 6 months through 4 years) and Moderna's pediatric formulation (ages 6 months through 5 years). Topics covered by ODH staff will include ordering, preparation, storage, handling and administration guidance.
