

Home Medical Equipment Service Providers Update November 2019

New Rules - Effective December 15, 2019

Effective December 15, 2019, new rules will go into effect for home medical equipment (HME) service providers. Links to the new rules are provided below.

Important Notice for Licensed Home Medical Equipment Service Providers

On or before **June 30, 2022**, all licensed HME service providers **located outside of Ohio** are required to obtain registration (<u>i.e. obtain national accreditation</u>) as a HME service provider [OAC 4729:11-2-01 (H)].

Notification of a Designated Representative by December 15, 2019

Per rule 4729:11-2-02, a designated representative is responsible for compliance with all applicable state and federal laws, regulations, and rules governing the provision of HME services. The designated representative shall be physically present at the licensed or registered location for a sufficient amount of time to provide supervision of the activities conducted by a HME service provider.

<u>ALL</u> licensed and registered HME service providers are required to electronically submit notification to the Board of the HME service provider's designated representative <u>no later than December 15, 2019</u>. All 2020 renewal information will be sent to the designated representative on file.

As part of the implementation of the new HME Service Provider rules, the Board has published inspection guides for both Licensed and Registered HME Service Providers. The guide, which mirrors the Board's internal inspection guide, serves as a reference for licensees, registrants, and applicants.

Licensed HME Service Providers - Continuing Education Providers

Continuing education can be provided as in-service education developed and taught by the licensed HME service provider, HME manufacturer, or any organization recognized by the Board that offers continuing education relevant to HME services. A licensed HME service provider or HME manufacturer does not have to be approved by the Board.
