New Outpatient Pharmacy Rules Effective 12/1/2020

Effective December 1, 2020, new rules for outpatient pharmacies (Chapter 4729:5-5 of the Administrative Code) go into effect. To assist licensees in complying with the new rule chapter, the Board recently published an outpatient pharmacy inspection guide (www.pharmacy.ohio.gov/OPinspect).

The inspection guide aligns with internal guidance used by Board inspectors and allows licensees to conduct self-inspections to ensure compliance. The guide also includes links to the new rules, important definitions, and reminders of when a licensee is required to submit notification or additional information to the Board.

To provide further guidance to licensees, the Board has opened a comment period for the inspection guide. This comment period will be open until **August 21, 2020**.

Following the conclusion of this comment period, the Board will review all comments and attempt to address or clarify any issues within the guide.

COVID-19 Update: Face Coverings Required in High-Risk Counties

Effective Wednesday, July 8, 2020, at 6:00 p.m., a new <u>Ohio Department of Health order</u> mandates face coverings in public in all counties that are designated as a Red Alert Level 3 Public Health Emergency or a Purple Alert Level 4 Public Health Emergency.

As of 7/9/2020, <u>twelve counties in Ohio are designated at Red Alert Level 3</u>, which indicates that individuals in the following counties have a very high risk of exposure and spread:

- Butler County
- Clermont County
- Cuyahoga County
- Fairfield County
- Franklin County
- Lorain County
- Hamilton County
- Montgomery County
- Pickaway County
- Summit County
- Trumbull County
- Wood County

New COVID-19 Waiver Issued

On July 7, 2020, the Board formally adopted FDA's <u>Temporary Policy on Prescription Drug Marketing</u> <u>Act Requirements for Distribution of Drug Samples During the COVID-19 Public Health Emergency</u> (June 2020), which authorizes Ohio-licensed drug distributors to deliver drug samples to a patient's home.
