**HB73 AUTHORIZE PRESCRIBING OFF-LABEL DRUGS** (GROSS J, LOYCHIK M) To authorize the prescribing of off-label drugs and if prescribed, to require their dispensing and to name this act the Dave and Angie Patient and Health Provider Protection Act.

**HB80 PHARMACIST CARE** (LIPPS S) Regarding pharmacist care.

**SB144 REGARDING IMMUNIZATIONS BY PHARMACISTS** (ROMANCHUK M) Regarding immunizations administered by pharmacists, pharmacy interns, and pharmacy technicians; regarding certificates of need and change of operator procedures for nursing homes; regarding the per Medicaid day payment rate for specified ICFs/IID; regarding medication aides and certified nurse aides, including competency evaluation programs and training and competency evaluation programs; regarding nursing home quality improvement projects; regarding conditional employment in homes and adult day care programs; regarding grants provided to adult day care providers; and regarding the Ohio Medical Quality Foundation.
