Rule Reorganization Crosswalk Available

In 2016, the State of Ohio Board of Pharmacy voted to authorize the reorganization of its administrative rules. The goal of this reorganization was to ensure that licensees could better identify rules applicable to the various practice settings/professions regulated by the Board.

As this process is now complete, the Board recently published a crosswalk document (<u>www.pharmacy.ohio.gov/crosswalk</u>). The document includes links to the reorganized Board of Pharmacy rules, the effective date of the reorganized rules, and links to the previous version of the rules that were in effect prior to the reorganization (if applicable).

Institutional Pharmacy and Facility Rules Effective Today (2/1/22)
