## Updated Home Medical Equipment Services Provider Rules - Effective 6/30/2025

Effective 6/30/2025, the following home medical equipment (HME) services provider rules go into effect:

- [4729:11-1-01](#): Definitions – home medical equipment. **(AMEND)**
- [4729:11-2-01](#): Licensure, registration and renewal. **(AMEND)**
- [4729:11-2-02](#): Designated representative. **(AMEND)**
- [4729:11-2-03](#): Applications. **(AMEND)**
- [4729:11-2-04](#): Recognized accrediting bodies. **(NO CHANGE)**
- [4729:11-2-05](#): Change in description of a HME services provider or discontinuation of business. **(AMEND)**
- [4729:11-3-01](#): Minimum standards for licensed home medical equipment services providers. **(AMEND)**
- [4729:11-3-02](#): Record keeping. **(AMEND)**
- [4729:11-3-03](#): Inspections and corrective actions. **(AMEND)**
- [4729:11-3-04](#): Continuing education. **(NO CHANGE)**

- [4729:11-3-06](#): Minimum standards for registered home medical equipment services providers. **(NEW)**

Please note the Board of Pharmacy added one new rule, [4729:11-3-06](#), that establishes the minimum standards for a registered HME Services Provider. It closely mirrors the layout of [4729:11-3-01](#), which discusses the minimum standards requirements for licensed HME Services Providers.

The Board has updated its HME inspection guides to reflect the upcoming changes to these rules. Among these changes:

- A question was added to the Licensed HME Service Provider inspection guide regarding restricting access to client records and home medical equipment to employees and authorized contractors only. ### Reminder of Compliance with Federal Rules for Registered HME Services Providers

For registered HME Services Providers and approved accrediting bodies, the Ohio Revised Code (ORC [4752.09](#)) requires compliance with the following:

*Federal rules issued pursuant to the Medicare program established under Title XVIII of the*

*"Social Security Act," 49 Stat. 620(1935), 42 U.S.C. 1395, as amended, relating to operations, financial transactions, and general business practices of home medical services providers.*

Therefore, registered entities and accrediting bodies are advised that they should comply with all applicable federal rules on supplier and quality standards including, but not limited to, the following:

- The Centers for Medicare and Medicaid Services "Durable Medical Equipment, Prosthetics, Orthotics, And Supplies (DMEPOS) Quality Standards" (**NOTE:** This specific standard is referenced in OAC [4729:11-3-06](#))

Failure for registered HME services providers to comply with these standards is considered a violation of ORC 4752.09 (B)(12) and may subject the registrant to administrative sanctions.
