9:04 a.m. Pursuant to Section 4729.571 of the Ohio Revised Code, the Ohio Board of Pharmacy convened in the Hearing Room, 17th Floor, of the Vern Riffe Center for Government and the Arts, 77 South High Street, Columbus, Ohio, for the purpose of considering summary suspensions as authorized by Section 4729.571 of the Ohio Revised Code, with the following members present:
