#### Ohio's New Opioid Prescribing Guidelines for Acute Pain Expand Fight Against Prescription Drug Abuse

The Governor's Cabinet Opiate Action Team recently released new acute pain opioid prescribing guidelines to keep patients safe. These new guidelines urge prescribers to first consider non-opioid therapies and pain medications for the management of acute pain when appropriate to avoid the potential misuse and abuse of opioids. When opioid medications are necessary to manage a patient's acute pain, the guidelines recommend that the clinician prescribe the minimum quantity necessary without automatic refills.

### New OARRS Rules for Pharmacists Effective February 1, 2016

On February 1, 2016, updates to rule 4729-5-20 of the Ohio Administrative Code became effective. This updated rule includes new requirements on when a pharmacist is required to review patient information in the Ohio Automated Rx Reporting System (OARRS). To assist pharmacists in the implementation of this updated rule, the Board has put together a one-page fact sheet and pocket card that provides the circumstances in which a pharmacist will have to query OARRS.

# Updates to Medical Board Rules on Prescribing Controlled Substances for Weight Loss & Binge Eating Disorder

On December 31, 2015, the following rules were recently adopted/updated regarding the use of controlled substances for weight loss and the treatment of binge eating disorder:

<u>Rule 4731-11-03</u>: Permits the prescribing of controlled substance stimulants for the treatment of binge eating disorder.

Rule 4731-11-04: Use of controlled substances to assist in weight reduction.

Rule 4731-11-04.1: Use of controlled substances for chronic weight management.
